- ReportThe JPA manager, Bill Tucker with Tucker-Alexander Insurance presented the Claims Cost<br/>for period ending March 31, 2016, (Attachment C). He mentioned the claims continue to improve for the<br/>current 15/16 year with 35 fewer claims and \$343,000 lower in total incurred than from the year prior.
- Bylaws & Agreement The JPA manager mentioned the need to amend the F.C.S.I.G. Bylaws and Agreement due to the withdrawal of two of the permanent members, Kings Canyon USD & Sanger USD. Amendment options will be explored with the goal of presenting the amended Bylaws and JPA Agreement for adoption at the June meeting.
- Golf Tournament The 30<sup>th</sup> annual Tucker / Magill Golf Tournament will be held this year at the Sunnyside Country Club on Thursday, 6/16/16. Tee time will be 9:30 a.m. instead of early afternoon. Entry forms will be emailed to interested members.
- Administrator's The F.C.S.I.G. claims administrator, Sharon Castillo with Tristar Risk Management mentioned as of 4/30/16, 59% of the reported claims are Medical Only Claims. This rate has been going up over the last several years which is a positive move as Medical Only Claims are not as costly as Indemnity/Lost Time Claims. It is hopeful to see a continuation of this trend with the implementation of the Return to Work program. As of 4/30/16, we have a \$256,000 lower total incurred from the prior year. This continues to be a very positive trend as last year was a good year and so far this year is even better.

Note: The decrease from the prior month total incurred was due to the development of a not-at fault custodian van accident claim.

# Loss ControlF.C.S.I.G. risk manager, Dr. Henry Brock mentioned the following districts received awards in their<br/>district size category for obtaining the lowest three year experience factor:

Fresno County Office of Education, Kingsburg Jt Union High School District, Washington Colony Elementary School District, and Clay Joint Elementary School District. Average Daily Attendance (ADA) was used to determine the composition of each group.

Progress is being made regarding the Return to Work (RTW) pilot study. The evaluation committee will be meeting in the near future to prepare a recommendation for the F.C.S.I.G. Board's consideration.
